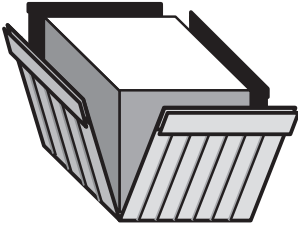

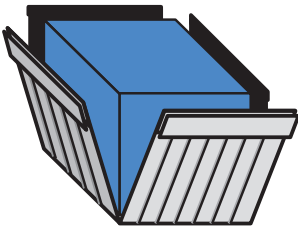

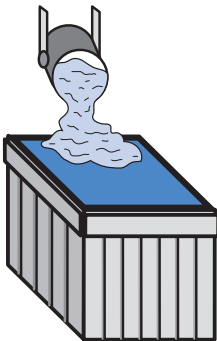
Cast In Place System



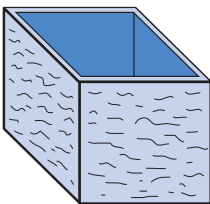
Empty mold with core



The **Universal Liner™** is placed over the core of the mold.



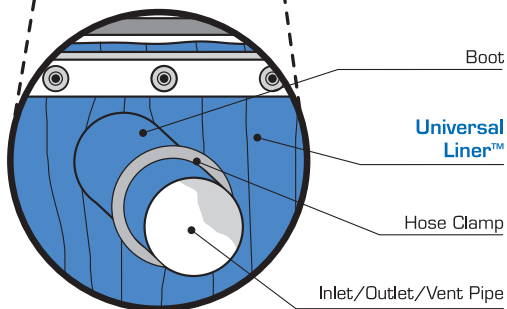
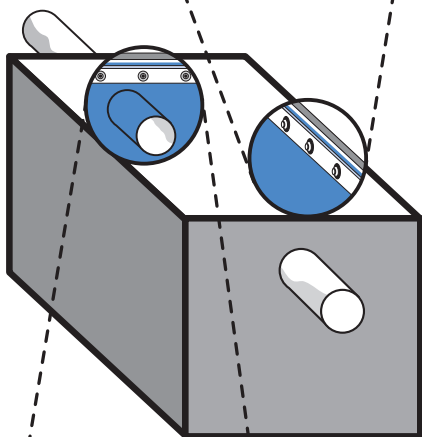
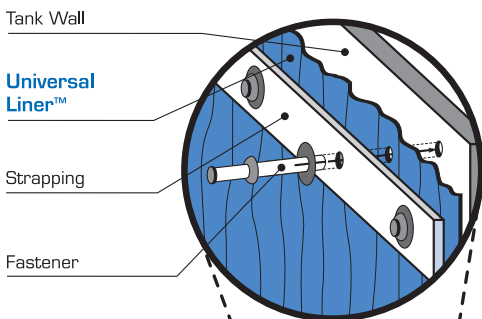
The mold is closed and cement is poured as normal directly on the **Universal Liner™**.
